Welcome! Please take the time to review the following office guidelines and policies so that we may better serve you. This information outlines our terms for providing service and will help clarify any questions you may have before making an appointment

Preparation Guidelines

Prior to your visit you need to obtain all the necessary paper work. We ask you to read and complete this paperwork at home (in non-urgent cases) to give you the time to think through your answers and make the most out of your time in our office. **Please print and fax/scan & e-mail the paper work or complete the online version and click the "Submit Form" button. An email with the document will automatically be generated to Red Tail Wellness.** Submitting your paper work ahead of time will allow the doctors to use your time most efficiently!

Medical Records

If applicable, please bring copies of your latest laboratory and imaging studies – no film required – on the day of your initial exam. Make copies if needed beforehand, as the copies we get from you will become part of our records. If your doctor requires an 'Authorization to Release Medical Records' form please contact our office and we will provide you one. Often your laboratory and imaging reports can be faxed.

Fees

Our goal at the Red Tail Wellness Centers is to provide you superior service at an affordable price. We do not accept medical insurance including HMO/PPO or Medicare/Medicaid. The Red Tail Wellness Centers have found it is better to focus on the patient 100%, rather than being limited by medical insurance, which impedes your health goals. We feel strongly in a quality versus quantity approach and we hope that in turn reflects faster recovery and greater satisfaction out of our diligence in care.

The Red Tail Wellness Centers is willing to fill out CSA 1500 or better known as a Health Insurance Claim Form (HCFA). After we submit the necessary information it is your responsibility to submit the form(s). The Red Tail Wellness Centers takes no responsibility for reimbursement (as we do not accept insurance assignment) and it is up to the insurance company to reimburse you (please also consider if your policy has out of network coverage).

We do accept Medicare as a Non-Participating Physician. This means we collect the full amount of your visit at the time of service and then send in your Medicare billing for you. Medicare and your secondary insurance policy (if you have one) will then reimburse you by sending a check directly to you in the mail. Medicare typically reimburses 80% of the fees listed under 'Medicare'.

When you pay at time of service our fee for the initial chiropractic evaluation (ranging from 45 – 90 minutes) is \$150. When you pay at time of service our fee for the initial functional medicine evaluation (90 minutes plus) is \$175. Additional visits are billed per the fee schedule below. No mark up is added on the ordering of tests, only the time required to read and interpret the results.

Retail Sales

Many doctors offer supplies (crutches, creams, supplements) at their offices for the convenience of their patients. The costs of these products, if needed, are not included in the evaluation or consultation fees. **No patient is required to purchase products from our office, however if you choose to purchase OTC products of lesser quality, you should not be surprised if you obtain sub-optimal results.**

Return Policy

Product returns must be made within thirty (30) days of purchase. Un-opened products (supplements/supplies) that are returned within thirty days will be given a full refund. All supplement returns must be unopened and sealed inside the original packaging. Opened supplements may not be returned. No refunds are offered on services rendered.

- 2) Your insurance policy is a legal contract between you, your employer and the insurance company. We, as healthcare providers, are NOT a party to that contract.
- 3) Regular appointments missed, or cancelled without providing 24 hours notice will be charged at the regular fee (\$73).
- 4) If the initial visit is missed and not rescheduled you will be billed the full amount (\$150).
